All that certain piece, parcel or lot of land on the Western side of Elaine Avenue in Chick Springs Township, Greenville County, State of South Carolina, being shown and designated as lot No. 22 on plat of the property of William M. Edwards, recorded in plat book S. at page 12, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the West side of Elaine Avenue, at joint corner of lots 22 and 21, and running thence with line of lot 21 S. 58-41 W. 254.7 feet to pin; thence S. 33-31 E. 75.05 feet to pin at rear corner of lot 23; thence with line of lot 23 N. 58-41 E. 251.8 feet to pin on Elaine Avenue; thence with the Western side of Elaine Avenue N. 31-19 W. 75 feet to the point of beginning.
