Locke, Jr. his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Chick Springs Township, being known and designated as lot No. 320, on Flat of Cherokee Forest, recorded in Plat Book EE at Pages 78 and 79, and being more particularly described as follows:

BEGINNING at an iron pin on the Southwestern side of Elizabeth Drive, at a concrete monument which is at the joint front corner of lots Nos. 320 and 318, and running thence with the rear line of lots Nos. 318 and 319, S. 56-30 W. 195 feet to an iron pin; thence N. 33-30 W. 100 feet to pin at rear corner of lot No. 321; thence with line of lot No. 321, N. 56-30 E. 195 feet to pin on Elizabeth Drive; thence with the Southwestern side of Elizabeth Drive, S. 33-30 E. 100 feet to the point of beginning.
