Know All Men by These Presents:

That I, Jeff R. Richardson in the State aforesaid, in consideration of the sum of Ten Dollars and no/100 (\$10.00) and exchange of DOLLARS, property to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jeff R. Richardson, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, and being known and designated as the rear portion of lots No. 29 and 30 as shown on plat of Roland Heights, said plat being recorded in the Office of R. L. J. in Plat Book S, Page 34 and described by courses and distances as follows:

Beginning at an iron pin on the South side of Alice Ave. at joint corner of lots No. 28 and 29 and running along the line of lot No. 28 S. 35-09 E. 175 feet to the joint rear corner of lots No. 28 and 31; thence along the line of lot No. 31 N. 52-16 E. 82 ft. to an iron pin on the line of lot No. 31; thence by a new line crossing the original lots Nos. 29 and 30 of Roland Heights N. 29-11 W. 176.5 ft. to an iron pin on the South side of Alice Ave., said point being 100.3 ft. from the intersection of Alice Ave. and Morgan Circle; thence along Alice Ave. S. 52-16 W. 100.3 ft. to the beginning.

This conveyance is made in accordance with and subject to the reservations and restrictions carried in an instrument affecting all of the property in the mentioned subdivision as recorded in Deed book 419, page 331 and reference is here made to that instrument for the terms and conditions of the restrictions and limitations.

The above described lot is a portion of lot No. 30 conveyed to me by W. W. Harling by deed dated July 19, 1954 and recorded in Deed Book 504, page 413 and a portion of lot No. 29 conveyed to me by Jeff R. Richardson, Trustee by deed dated September 22, 1950 and recorded in Deed Book 419, page 430.
