to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. ALVIN GILREATH, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 79, Section I, of Lake Forest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 17, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Lake Fairfield Drive, joint front corner Lots 79 and 80 and running thence N. 29-46 W., 169.3 feet to an iron pin, joint rear corner Lots 56, 57, 79 and 80; thence S. 59-24 W., 93 feet to a point in a drainage easement; thence through the said drainage easement S. 51-0 W., 26.9 feet to a point in the said drainage easement, being the joint rear corner of Lots 78 and 79; thence through the said drainage easement along the common line of Lots 78 and 79 S. 36-19 E., 170 feet to an iron pin on the Northerly side of Lake Fairfield Drive, joint front corner Lots 78 and 79; thence along the Northerly side of Lake Fairfield Drive N. 54-56 E., 100 feet to an iron pin, the point of beginning.

The above-described property is conveyed subject to recorded and existing building restrictions, easements and rights-of-way.
