All those lots of land situate on the South side of Miller Street, in the City of Greenville, Greenville County, S. C. and being shown as lots 4, 6, 8 and a portion of lot 10 on plat of property of W. N. Miller and E. E. Stone, made by W. D. Neves, Engineer, March 27, 1915, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book C, Page 235, and having, according to said plat and a recent survey made by Dalton & Neves, Engineers, October 1954, the following metes and bounds to-wit:

BEGINNING at an iron pin on the South side of Miller Street at the Southwest corner of intersection of Miller Street and a 10 foot alley, running thence along the South side of Miller Street N. 89-45 W. 134 feet to an iron pin in the front line of Lot No. 10; thence running through Lot No. 10 S. 3-35 E. 104.1 feet to an iron pin on the North side of an 8 foot alley; thence along the North side of said 8 foot alley N. 76-30 E. 127.9 feet to an iron pin at the Northwest corner of the intersection of an 8 foot alley and a 10 foot alley; thence along the West side of said 10 foot alley N. 2-15 E. 74 feet to an iron pin on the South side of Miller Street, the beginning corner.
