to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. LEWIS STOVER, his Heirs and Assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being on the northwest side of Lakecrest Drive in the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as the major portion of Lot 26, Section 1, on plat of Stone Lake Heights, Section 1, made by Piedmont Engineering Service dated June 1952, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "BB" at page 133, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Lakecrest Drive at the joint front corner of Lots 25 and 26, Section 1, and running thence along the line of Lot 26, N. 72-35 W 169.5 feet to an iron pin on the southeast side of Chick Springs Road; thence along the southeast side of Chicks Springs Road, N. 34-10 E. 137 feet to an iron pin at the joint rear corner of Lots 26 and 27; thence running through Lot 26 in a southeasterly direction 137 feet, more or less, to a point in the front line of Lot 26 (which point is S. 22-18 W. 5 feet from the joint front corner of Lots 26 and 27); thence along the northwest side of Lakecrest Drive, S. 22-18 W. 115 feet to the beginning corner.

The above described lot is the same conveyed to the grantor, herein, by deed of Vance E. Stafford, dated March 26, 1954, and recorded in the R. M. C. office for Greenville County, S. C., in Deed Book 497, at page 2.

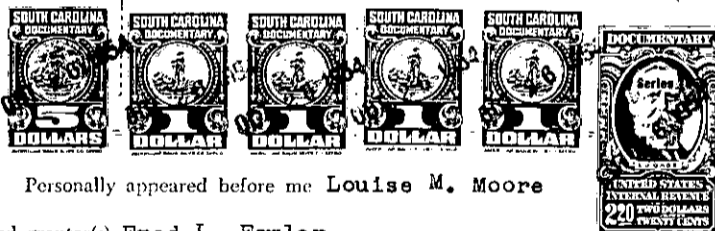
