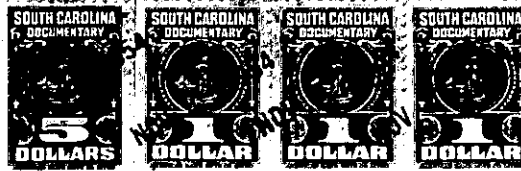

Know All Men by These Presents:

That I, W. H. ALFORD

in consideration of the sum of Three Thousand Nine Hundred Ninety-nine and 27/100 DOLLARS, AND ASSUMPTION OF MORTGAGE REFERRED TO BELOW, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said MARGARET P. DAWES, her heirs and assigns, forever:

FILED GREENVILLE in the State aforesaid, NOV 24 1954 FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION R.M.C.

All that lot of land with the buildings and improvements thereon, situate on the Southwest side of White Oak Drive in the City of Greenville in Greenville County, S. C., being shown as Lot No. 44 on plat of University Circle, made by Piedmont Engineering Service, May, 1948, recorded in the R.M.C. Office for Greenville County S. C. in Plat Book "Y", Page 111, and having, according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southwest side of White Oak Drive at joint front corner of lots 43 and 44 and running thence along the line of lot 43 S. 56-48 W. 123.3 feet to an iron pin; thence S. 35-39 E. 69.6 feet to an iron pin; thence along the line of lot 45 N. 56-15 E. 131.8 feet to an iron pin on the Southwest side of White Oak Drive; thence along the Southwest side of White Oak Drive N. 42-48 W. 70 feet to the beginning corner.

As a part of the consideration of this conveyance, the grantee assumes and agrees to pay the balance due on that mortgage given by W. H. Alford to Fidelity Federal Savings and Loan Association, dated March 20, 1953, recorded in the R.M.C. Office for Greenville County, S. C. in Mortgage Book 557, page 10.

This is the same property conveyed to me by deed of Central Realty Corporation, dated February 17, 1953, recorded in the R.M.C. Office for Greenville County in Deed Book 474, page 459.

Grantee to pay 1954 taxes.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
