Know All Men by These Presents:

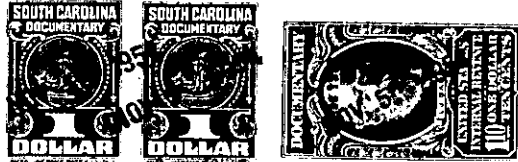
That We, P. L. Bruce, Nora B. Bruce and Thomas S. Bruce, in the State aforesaid, in consideration of the sum of Six Hundred Fifty (\$650.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Toy Brown, his heirs and assigns forever,

ALL That certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State aforesaid, being known and designated as Lots Nos. 8 and 9, according to a plat of property of P. L. Bruce, prepared by R. K. Campbell, recorded in the Office of the Register of Mesne Conveyance in Plat Book W, at Page 171, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the Northwest side of an unnamed street, joint front corner of Lots Nos. 7 and 8, and running thence along said unnamed street, S. 34-55 W., 120 feet to a point on the Northwest side of said unnamed street, joint front corner of Lots Nos. 9 and 10; thence along the joint line of Lots Nos. 9 and 10, N. 55-05 W., 140 feet to a point, joint rear corner of Lots Nos. 9, 10, 18 and 19; thence along the joint rear line of Lots Nos. 9, 8, 19 and 20, N. 34-55 E. 120 feet to a point, joint rear corner of Lots Nos. 7 and 8, 20 and 21; thence along the joint line of Lots Nos. 7 and 8, S. 55-05 E., 140 feet to a point on the Northwest side of said unnamed street, the beginning corner.

By deed dated March 5, 1952, the grantors herein inadvertently purported to convey to the grantee herein Lots Nos. 9 and 10 instead of Lots Nos. 8 and 9, which was the intent of the parties. This deed is being executed to correct said mistake and to convey the property sold and no additional consideration has been paid.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
