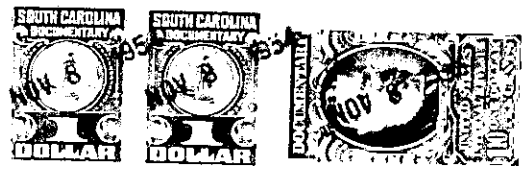
That I, Belle Hardin Gantt in the State aforesaid,

All those certain lots of land in Greenville County, State of South Carolina, being known and designated as lot Nos. 71, and 72 on the Southern side of Gantt Drive, and lot No. 26 on the Northern side of Cambridge Drive, as shown on a plat of Brookwood, recorded in Plat Book BB at Page 27, and being more particularly described according to said plat as follows:

LOT Nos. 71 and 72: BEGINNING at an iron pin on the Southern side of Gantt Drive, joint front corner of lots 70 and 71, and running thence with joint line of said lots, S. 2-15 W. 165 feet to iron pin; thence S. 87-30 E. 200 feet to an iron pin, rear corner of lot 73; thence with line of said lot, N. 2-15 E. 165 feet to an iron pin in the Southern side of Gantt Drive; thence with said Drive, N. 87-30 W. 200 feet to the beginning corner.

LOT No. 26: BEGINNING at an iron pin on the Northern side of Cambridge Drive, joint front corner of lots 25 and 26, and running thence with joint line of said lots, N. 2-15 E. 165 feet to an iron pin, rear corner of lot 36; thence with line of said lot, N. 87-30 W. 100 feet to iron pin, rear corner of lot 27; thence with line of said lot, S. 2-15 W. 165 feet to an iron pin in the North side of Cambridge Drive; thence with said Drive, S. 87-30 E. 100 feet to the point of beginning.
