to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Joseph G. Mann and John P. Mann, their Heirs and Assigns forever:

All that piece, parcel or tract of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the south side of the White Horse Road near the intersection of said Road with the Augusta Road and containing seven and one-half acres, more or less, according to a Plat thereof prepared by Piedmont Engineering Service on November 10, 1954 recorded in the R. M. C. Office for Greenville County in Plat Book HH, Page 175 and being more particularly described according to said Plat, as follows, to-wit:

BEGINNING at an iron pin on the south side of the White Horse Road 144.4 feet in a westerly direction from the corner of the view right-of-way line at the intersection of the White Horse Road and the Augusta Road, U. S. Highway #25 corner of Property of A. C. Mann and running thence with his line S. 52-17 W. 180 feet to an iron pin; thence still with his line S. 31-09 W. 694.5 feet to an iron pin in center of Air Base Railway Siding corner of A. C. Mann land; thence with his line and the center of said Air Base Railway Siding N. 25-46 W. 710 feet to an iron pin on line of Gregory Property; thence with his line N. 66-53 E. 599.8 feet to an old iron pin; thence S. 36-22 E. 41.5 feet to an old iron pin; thence N. 55-52 E. 114.8 feet to an old iron pin on the White Horse Road; thence with said Road S. 32-49 E. 174.3 feet to an iron pin; thence still with said Road S. 36-43 E. 70 feet to an iron pin, the beginning corner.

The above is the same property conveyed to me by Clinton Abraham by his deed dated November 9, 1954 to be recorded.
