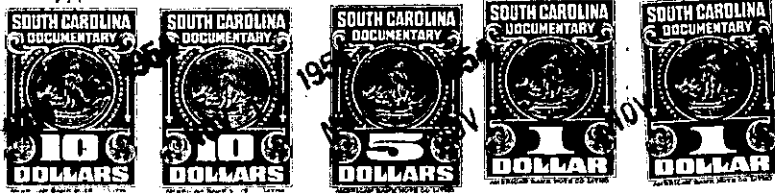

hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and

released, and by these presents does grant, bargain, sell and release unto

William Glenn Ivester, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, on the west side of Stokes Street, and being known and designated as Lot No. 33 of a subdivision known as Cordell Subdivision No. 10 as shown on plat thereof made by C. C. Jones, Engineer, and recorded in the R. M. C. office for Greenville County in Plat Book BB, at page 84, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of Stokes Street at the corner of Lot No. 34, and running thence along the line of said lot, N. 61-55 W. 187.6 feet to an iron pin at the rear corner of said lot; thence N. 22-35 E. 75.9 feet to an iron pin at the rear corner of Lot No. 31; thence along the line of said Lot No. 31, S. 73-14 E. 189.4 feet to an iron pin on the west side of Stokes Street; thence along the west side of Stokes Street, S. 11-16 W. 43.3 feet to a bend; thence S. 27-43 W. 44 feet to an iron pin at a bend; thence S. 36-00 W. 26.9 feet to the beginning corner; being a portion of the property conveyed to grantor corporation by Louise Earle and India E. Pepper by deed dated September 25, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 463, at page 503.

The above described lot is shown on the Township Block Book at Sheet 240, Block 1, Lot 35, and the grantor is to pay taxes for the year 1954.
