unto the said Minta G. Woods, her heirs and assigns, forever

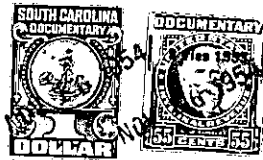
All that piece, parcel or lot of land in Greenville County, State of South Carolina
