to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. E. Shaw and Elvie S. Shaw, their heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, and being known and designated as Lot Number 43 of the property of Central Development Corporation according to a map of division of a portion of Lots 18 and 19 of a subdivision known as Essex Court a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book DD at Page 165, and having the following metes and bounds, to-wit:

Beginning at a point on the Northwestern side of Alpine Way at the joint front corner of lots 43 and 44 and running thence N. 50-41 W. 169.3 feet to a point at the joint rear corner of Lots 43 and 44; thence S. 39-22 W. 131.3 feet to a point; thence S. 01-22 E. 44.6 feet to a point on the Northern side of Dellwood Drive; thence with the Northern side of Dellwood Drive N. 85-06 E. 202.6 feet to a point at the Northwestern intersection of Dellwood Drive with Alpine Way; thence with the Northwestern side of Alpine Way N. 39-19 E. 19.2 feet to the point of beginning.

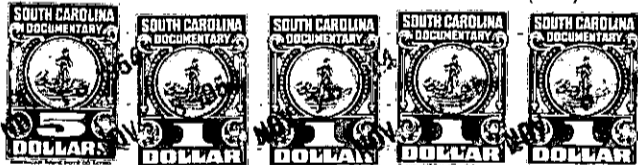
