to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s)

## C. B. Jones, his Heirs and Assigns forever.

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Butler Township, in the Rocky Creek Church community, being bounded on the north by lands of B. H. Hudson, on the east by the Roper Mountain Road, on the south by other lands of myself and lands of C. B. Jones and on the west by lands of C. B. Jones, and being a part of the same land that was conveyed to me by deed from J. A. Forrester, November 1st 1924, recorded in the office of the R. M. C. for Greenville County in Deed Book 91 at page 580, and having the following courses and distances,

Beginning on a stake on the common line of the grantor and the grantee herein and at a point 156 feet from the joint corner of the said grantor and grantee herein, and runs thence N. 38-30 E. 236 feet to a nail and stopper in the western edge of the surfaceing of the said Roper Mountain Road (iron pin back on line at 11 feet); thence with the said road, N. 47-30 W. 244 feet to a nail and stopper in the center of the said road and on the line of B. H. Hudson; thence with the Hudson line S. 47-30 W. 383 feet to a stake, joint corner of the Hudson land and of the grantee herein; thence N. 78-39 E. 254 feet to an old iron pin, joint corner of the grantor and the grantee herein; thence with the old common line S. 25-00 E. 156 feet to the beginning corner, containing One and Forty Five One-hundredths (1.45) acres, more or less.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
