all that piece, parcel or lot of land in Austin Township, Greenville

County, State of South Carolina, located on the North-West side of Dalewood Drive, North of the Town of Simpsonville, being known and designated as lot No. 55 and 56 on a plat of property of D. L. Bramlett, subdivision known as "Dalewood Heights", plat thereof made by C. O. Riddle, Surveyor, in February 1953 and recorded in Greenville County R. M. C. Office in Plat Book at page, this said plat being a part of lands as shown on a larger plat of property of Mrs. Rosa J. Bramlett, recorded in Plat Book "F" at page 278 in the Greenville County R. M. C. Office, said lots 55 and 56 being more fully describes as follows:

BEGINNING on the North side of Dalewood Drive at corner of lot No. 54, said corner being on culvert, and running thence along line of lot No. 54, N. 47-17 W. 350 feet across branch to an iron pin on line of lot No. 56; thence along back line of lot No. 54, N. 42-43 E. 135 feet to iron pin on line of lot No. 53; thence along line of lot No. 53, N. 47-17 W. 100 ft. to iron pin; thence along line of lot No. 57, S. 42-43 W. 384.4 feet to iron pin on Dalewood Court (proposed street); thence along said proposed Dalewood Court, S. 49-00 E. 450 feet to iron pin on Dalewood Drive; thence along Dalewood Drive, N. 42-43 E. 236.2 feet to the beginning corner.
