Know All Men by These Presents:

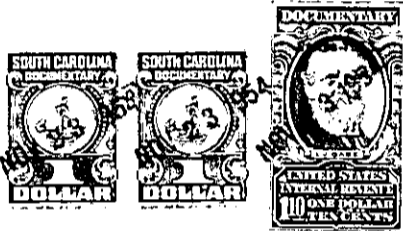
That L. GERTRUDE HUDSON WALDROP in the State aforesaid,
