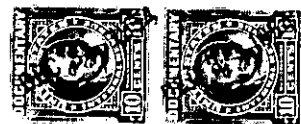

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto LYLE E. MCGILVRA:

All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northeastern side of Harrington Avenue in a subdivision known as Isaqueena Park, being known and designated as Lot No. 78 of said subdivision, and being as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P at pages 130-131. The within conveyed premises have according to said plat the following metes and bounds:

BEGINNING at a point on the Northeastern side of Harrington Avenue at the joint front corner of Lots Nos. 77 and 78, and running thence N. 32-51 E. 120 feet to a point, the joint rear corner of Lots Nos. 77 and 78; thence S. 69-06 E. 115 feet to a point, the joint rear corner of Lots Nos. 78 and 79; thence S. 45-21 W. 154.7 feet to a point on the Northeastern side of Harrington Avenue, the joint front corner of Lots 78 and 79; thence along the Northeastern side of Harrington Avenue N. 47-30 W. 60 feet to a point; thence continuing with the Northeastern side of Harrington Avenue N. 03-03 W. 20 feet to the beginning corner.



The above described property is subject to certain restrictive covenants applicable to Isaqueena Park Subdivision recorded in the R.M.C. Office for Greenville County.
