 released, and by these presents does grant, bargain, sell and release unto

EVA McDONALD TIMMONS, Her Heirs and Assigns:

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville, and being known and designated as Lot Number 124 and the Northern half of Lot Number 123 of a subdivision known as Vista Hills, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book P at Page 149, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southeastern side of Chick Springs Road at the joint front corner of Lots 124 and 125 and running thence S 48-48 E 206.7 feet to a point in the center of a 15-foot alley; thence with the center of said 15-foot alley S 42-42 W 102.5 feet to a point, said point being 32.5 feet Southwest of the joint rear corner of Lots 123 and 124; thence N 56-28 W 193.1 feet to a point on the Southeastern side of Chick Springs Road, said point being 40 feet Southwest of the joint front corner of Lots 123 and 124; thence with the Southeastern side of Chick Springs Road N 35-58 E 128.8 feet to the point of beginning.

THE ABOVE description includes one-half of a 15-foot alley at the rear of this property, but it is distinctly understood and agreed that this rear 7½ feet of this property, together with the rear 7½ feet of the lots adjoining it in the rear, shall be used as a public alley, as shown on said plat for Vista Hills.

THIS deed is executed subject to existing and recorded restrictions and rights-of-way.

GRANTEE to pay 1954 taxes.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the grantee.
