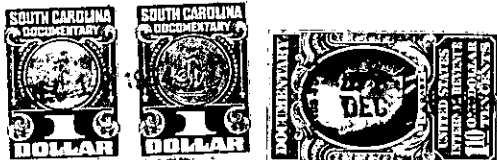
D. C. BRYSON, His Heirs and Assigns:
