to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charlotte B. Wilson, her heirs and assigns forever:

All that certain piece, parcel or lot of land on the West side of Second Avenue, in Section No. 3 of Judson Mills Village in the County of Greenville, State of South Carolina, being known and designated as lot No. 3, as shown on a plat of Section No. 3 of Judson Mills Village made by Dalton & Neves, Engineers, in March 1940, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book K, at Page 42, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Second Avenue, joint front corner of lots Nos. 3 and 4, which iron pin is 323 feet North of the Northwest corner of the intersection of Second Avenue and Sixth Street, and running thence with the line of intersection of Second Avenue and Sixth Street and running thence with the line of lot No. 4, N. 83-49 W. 119.3 feet to an iron pin, joint rear corner of lots Nos. 23 and 24; thence with the rear line of lot No. 24, N. 6-11 E. 80 feet to an iron pin, joint rear corner of lots Nos. 2 and 3; thence with the line of lot No. 2, S. 83-49 E. 119.33 feet to an iron pin on the West side of Second Avenue; thence with the West side of Second Avenue, S. 6-12 W. 80 feet to the beginning corner.

This being the same property conveyed to the grantor by deed of J. H. Mauldin March 30, 1950 and recorded in the R. M. C. Office for Greenville County in Deed Book 406 at page 26.
