That I, David U. Mauldin, of Greenville County, in the State aforesaid, in consideration of the sum of Seventy-Five Hundred and No/100 - - - (\$7500.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Thomas V. Bowers, his heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, being known and designated as Lot No. 1 of a subdivision of the property of Roy Bass as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book U, at page 139, which plat is a resurvey of Lots Nos. 20, 21, 22, 23 and 24 of a subdivision known as Fallis Annex as shown on plat recorded in the R. M. C. office for Greenville County in Plat Book C, at page 100, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Bradley Street at the corner of Lot No. 25, of Section 1, of Fallis Annex, and running thence along the line of that lot, N. 64-30 E. 200 feet to an iron pin; thence S. 24-00 E. 105 feet to an iron pin at the corner of Lot No. 2 of the Bass property; thence along the line of that lot, S. 64-30 W. 200 feet to an iron pin at the corner of said lot on the east side of Bradley Street; thence along the east side of Bradley Street, N. 24-00 W. 105 feet to the beginning corner.

This lot is composed of all of Lot 24 and 42 feet of Lot No. 23 of Section 1 of Fallis Annex.

The above described property is a portion of the same conveyed to me by Roy Bass Motor Company, Inc. by deed dated October 29, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 512, at page 263.

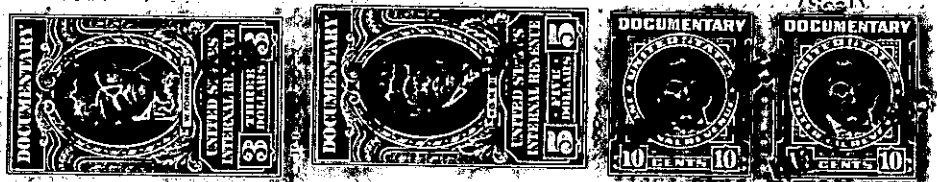
