South Carolina State Highway Department, its successors and assigns:

All those pieces, parcels or lots of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 31 and 32 of property of P. L. Bruce, according to a plat of said subdivision recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book W, at page 171, and having, according to said plat, the following metes and bounds, to-wit:
