Daniel W. McClain, his heirs and assigns forever:

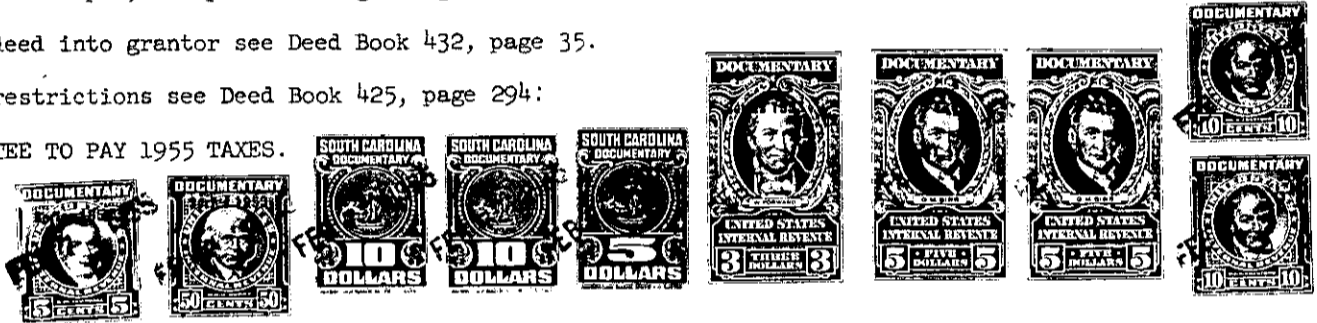
