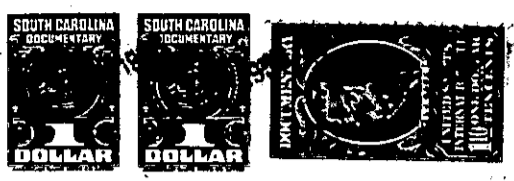

Grady Forrester to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) J. Grady Forrester and his heirs and assigns forever:

All of that parcel or tract of land in Highland Township of Greenville County, South Carolina, located on the East side of the Greer-Landrum Highway (No. 14), about ten miles North from Greer, bounded by said highway and lands of the W.T. Forrester Estate, containing 2.12 acres, more or less, and having the following courses and distances: BEGINNING on a stake on an old line, the northeastern corner of the lot herein conveyed, and runs thence N. 74.30 W. 650 feet to a point in said State Highway No. 14; thence with said highway S. 54 W. 174 feet to a point in said highway; thence S. 71.30 E. 172 feet to a stake; thence S. 86.45 E. 135 feet to a stake; thence S. 65.00 E. 290 feet to a stake; thence N. 86.45 E. 105 feet to a stake; thence N. 67 E. 66 feet to a stake; thence N. 27 E. 91 feet to the beginning corner, and being all of that lot of land

conveyed to the grantor by Lillian Forrester, et al, by deed recorded in the R.M.C. Office for Greenville County in Deed Book 313, at page 157. See also deed recorded in Deed Book 412, at page 470.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
