Know All Men by These Presents:

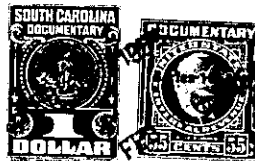

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert D. Poole, his heirs and assigns, forever:

All those pieces, parcels or lots of land situate on the Southwest side of the Jones Gap Road, near River Falls, in Cleveland Township, in Greenville County, South Carolina, shown as Lots 3 and 4 on plat of River Falls Subdivision No. 2, made by J. C. Hill, Surveyor, August 22, 1949, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "Z" at page 21, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of the Jones Gap Road at joint corner of Lots 4 and 5 and running thence along the line of Lot 5, S 54-25 W 222.2 feet to an iron pin in the center of an unnamed road; thence along the center of said road in a Southeasterly direction, 75 feet to an iron pin at joint rear corner of Lots 3 and 4; thence continuing with the center of said road in a Southeasterly direction, 80 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the line of Lot 2, N 54-25 E 166.6 feet to an iron pin in the center of the Jones Gap Road; thence with the center of the Jones Gap Road, N 7-0 W 36.2 feet to an iron pin; thence still with the center of Jones Gap Road N 22-10 W 125.6 feet to the beginning corner.

This is a portion of that property conveyed to me by deed of L. A. Moseley and J. H. Canron, recorded in the said R. M. C. Office in Deed Book 349, page 104. Grantee to pay 1951 taxes.
