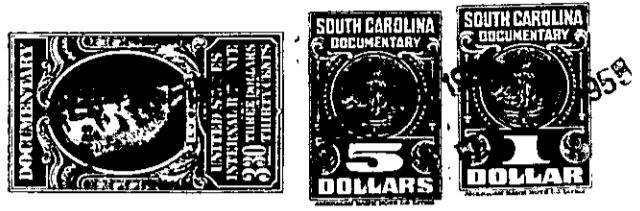

KNOW ALL MEN BY THESE PRESENTS, That... I, John D. Neely, of Potter County, Texas, in the State aforesaid, in consideration of the sum of ... Three Thousand and No/100 ... Dollars to me in hand paid at and before the sealing of these presents by R. J. Fisher (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. J. Fisher, his Heirs and Assigns forever

all that piece, parcel or lot of land in Township, Greenville County, State of South Carolina, in the Jordan Community, lying on the east side of the Jordan Road, and having the following courses and distances, to wit:-
Beginning at a stone on the west side of the Jordan Road and runs thence with the said road 11.04 chains to a stake at the forks of the road; thence South 80 1/2 degrees East 12.35 chains to an iron pin in the center of another road; thence North 55 3/4 degrees East 8.43 chains to an iron pin in the said road; thence North 83-00 degrees West 1.56 chains to a stone, corner of J. B. Henson's line; thence North 35 1/2 degrees West 5.68 chains to a stake which is seven links from a stone corner; thence North 82 1/2 degrees West 19.14 chains to the beginning corner, containing eighteen and seven-teen one-hundredth (18.17) acres, more or less.

ALSO all that other certain piece, parcel or lot of land adjoining the above described tract of land, situate, lying and being in the said County and State, lying on the east side of the Jordan Road, and lying across the said road from the former home of G. W. Neely (now E. G. Sherbert), bounded by lands formerly of W. T. Henson, J. L. Babb and G. W. Neely, containing two and three tenths (2.3) acres, more or less, and having the following courses and distances, to wit:-
Beginning on a stone in the edge of the said Jordan Road in front of the former home of G. W. Neely and runs thence South 81 1/2 degrees East 8.93 chains to a stone; thence South 62 1/4 degrees West 8.53 chains to a stone on the Jordan Road; thence along the said road North 13 degrees West 5.50 to the beginning corner; both tracts being further shown and identified by a plat thereof attached.

This is the same lands conveyed to John D. Neely by certain Warranty Deeds, one dated February 24th 1941 executed by Ivon Neely to J. D. Neely (being one and the same as John D. Neely) recorded in the R. M. C. office for Greenville County, South Carolina, in Deed Book _____ at page _____, and the other deed bearing date of January 3rd 1946 executed by E. G. Sherbert to John D. Neely recorded in the office of the R. M. C. for Greenville County, South Carolina, in Deed Book _____ at page _____, to which reference is hereby made for more particular details.
