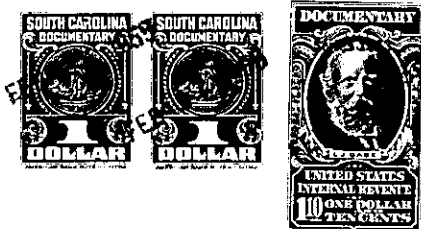

BEGINNING at an iron pin on the Northern side of Manhattan Boulevard at the joint front corner of lot Nos. 82 and 83 and running thence with the joint line of said lots N. 25-15 E. 216 feet to an iron pin; thence along the joint rear line of lots 8 and 83, N. 64-45 W. 100 feet; thence along the joint line of Lots 9, 10, 11 and 83, S. 25-15 W. 220 feet to an iron pin on Manhattan Boulevard; thence with the Northern side of said Boulevard S. 65-45 E. 47.4 feet and S. 68-28 E. 52.7 feet to the beginning corner.
