to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William Edward Loftis and Louise W. Loftis, their Heirs and Assigns forever,

All that lot of land in Chick Springs Township, Greenville County, South Carolina, on the Northwestern side of Mabel Avenue, shown as Lot No. 257 on Plat of the Property of Robert J. Edwards, made by Dalton & Neves in May, 1951, and having according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Mabel Avenue, at the joint front corner of Lots Nos. 257 and 258, and running thence with the line of Lot No. 258, N. 47 W. 200 feet to iron pin at rear corner of Lot No. 200; thence with the rear line of said lot, N. 43 E. 90.3 feet to iron pin, rear corner of Lot No. 256; thence with the line of said lot; S. 47 E. 200 feet to iron pin on Mabel Avenue; thence with the Northwestern side of Mabel Avenue, S. 43 W. 90.3 feet to iron pin, the point of beginning.

It is understood that this conveyance is made subject to the following restrictions, which are expressly made a part of the consideration thereof, and that the same are for the benefit of the Grantor, Grantees, and all other persons owning lots shown on said Plat above mentioned:

- (1) Said lot shall be used exclusively for residential purposes.
- (2) No dwelling shall be erected on said lot containing less than 1200 square feet of floor space, exclusive of porches and breezeways.
- (3) No temporary buildings shall be used for residential purposes, nor shall any garage apartment be constructed on said lot.
- (4) The outer or exterior walls of any residential dwelling shall be of material other than concrete blocks.
- (5) No building of any kind, or residence shall be constructed nearer than 50 feet from the front line of said lot.

Grantees are to pay 1955 taxes. TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining


TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
