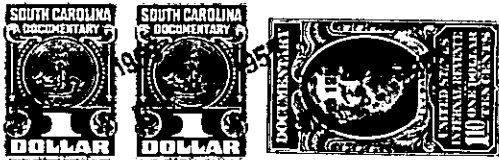

All that piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina and being known and designated as lots Nos. 17, 35, 36, 61 and 29 of a subdivision known as Forest Park, plat recorded in Plat Book EE, Pages 64 and 65; reference to which is hereby craved for more complete description. This property was formerly known as Gresham Park. A partial plat thereof being recorded in R. M. C. Office for Greenville County in Plat Book BE, Pages 70 and 71. This is part of same property conveyed to me by William C. Gresham, Sr. and Wilbon H. Gresham by deed dated November 6, 1953 and recorded in Deed Book 488 Page 267 in R. M. C. Office for Greenville County. The above property is being conveyed subject to the following restrictions:

- 1: No commercial building to be erected on said premises.
- 2: No dwelling shall be erected costing less than \$10,000.00.
- 3: Any dwelling erected must be at least 35 ft. or more from street.
- 4: No live stock such as horses, cattle, pigs, chickens, etc. shall be housed or pastured on premises.
- 5: Any dwelling constructed must be equipped with modern plumbing and either connected to sewer line or a satisfactory septic tank.
