M. C. Office for Greenville, South Carolina, in Plat Book "Y", at Page 140, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Woodbine Drive at joint front corners of Lots No. 103 and 104 and running thence along the line of said Lot No. 103, S. 2-30 W. 200 feet to iron pin in line of Lot No. 106; thence along the line of said Lot No. 106, S. 87-30 E. 100 feet to iron pin at back corner of Lot No. 105; thence along the line of said Lot No. 105, N. 2-30 E. 200 feet to iron pin on Woodbine Drive; thence with the said Woodbine Drive, N. 87-30 W. 100 feet to iron pin at point of beginning.

- 2. No house is to be built closer than 50 feet to the street
- 3. No temporary house is to be erected on said lot.
