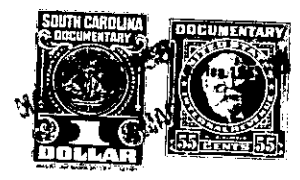

LOT 19 BEGINNING at an iron pin on the Northern side of Cambridge Drive, at corner of lots 18 and 19, and running thence with the joint line of said lots, N. 2-15 E. 165 feet to iron pin, rear corner of lot 43; thence with line of said lot, N. 87-45 W. 100 feet to iron pin, rear corner of lot 20; thence with line of said lot, S. 2-15 W. 165 feet to iron pin in the Northern side of Cambridge Drive; thence with said Drive, S. 87-45 E. 100 feet to the beginning corner.
