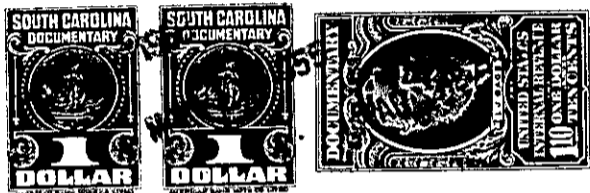

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Clyde L. Dorr, his heirs and assigns forever:

All that piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 23 of a subdivision known as Greenfields, Section 3, as shown on a plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book GG at page 93, and being described as follows:

BEGINNING at an iron pin on the western side of Dolphin Street, joint front corner Lots Nos. 23 and 24, and running thence with the joint lines of said lots, S. 80-42 W. 147.2 feet to an iron pin; thence S. 11-55 E. 70 feet to an iron pin on the northern side of a 25-foot easement; thence with said easement N. 82-45 E. 141 feet to an iron pin on the western side of Dolphin Street; thence with said street, N. 7-15 W. 75 feet to the beginning corner.
