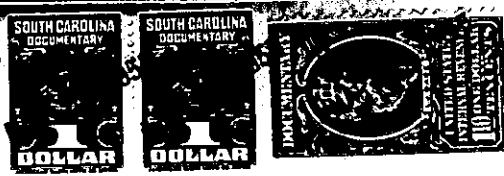

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. W. Mahon and Evelyn R. Mahon,

All that piece, parcel or lot of land, in Grove Township, in the County of Greenville, State of South Carolina, near the town of Piedmont, being known and designated as Lots Nos. 1, 2, 3, 4, and 5 of the property of C. B. Dalton, containing 6.9 acres, more or less, and having, according to a plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book DD, page 157, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of a county road at the joint front corner of Lots Nos. 5 and 6, which iron pin is 926 feet in a northwesterly direction from the intersection of said County Road and U. S. Highway No. 29, and running thence along the joint line of said Lots, S. 26-40 W. 527.4 feet to an iron pin in the line of Lot No. 1; thence along the line of Lot No. 1 and the rear line of Lots Nos. 6, 7, and 8, S. 40-0 E. 277.9 feet to an iron pin; thence N. 89-0 W. 478 feet to an iron pin in the line of the property of S. J. Dalton; thence along the line of the property of S. J. Dalton, N. 7-0 E. 879 feet to an iron pin in the southwestern side of said County Road; thence along the southwestern side of said County Road, S. 67-21 E. 165 feet to an iron pin; thence continuing along the southwestern side of said County Road, S. 62-02 E. 310 feet to the point of beginning; being the same conveyed to me by C. B. Dalton by his deed dated June 26, 1953, and recorded in the R. M. C. Office for Greenville County in Vol. 480, at page 533.
