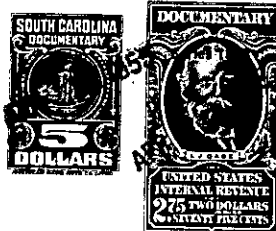

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 53, according to Plat of Section I of Lake Forest, which plat is recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book "CG", page 17, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeasterly side of Tranquil Avenue, joint front corner lots 53 and 54 and running thence S. 26-07 E. 164.3 feet to an iron pin, joint rear corner lots 53 and 54; thence N. 67-07 E. 120 feet to an iron pin on the westerly side of Shannon Drive; thence along the westerly side of Shannon Drive N. 29-51 W. 143 feet to an iron pin; thence around the curve of the intersection of Shannon Drive and Tranquil Avenue, the chord of which is N. 71-59 W. 37.9 feet to an iron pin on the Southeasterly side of Tranquil Avenue; thence along the southeasterly side of Tranquil Avenue S. 65-33 W. 85 feet to the point of beginning.
