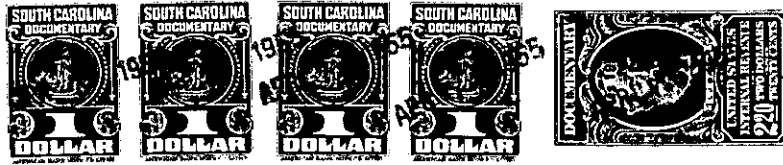
Know All Men by These Presents:

All that piece, parcel and lot of land, lying and being in Gantt Township, County of Greenville, State of South Carolina, near the City of Greenville, lying and being in that certain subdivision known as Belle Meade, according to a plat made by Piedmont Engineering Service and recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "EE" at Pages 116 and 117, being more particularly described as follows:

BEGINNING at an iron pin on the East side of Williamsburg Drive, at the joint front corner of Lots 5 and 6 and running thence along Williamsburg Drive N. 11-33 E. 70 feet to an iron pin, the joint front corner of Lots 4 and 5; thence along the joint line of Lots 4 and 5 S. 78-27 E. 150 feet to an iron pin, the joint rear corner of Lots 4 and 5; thence S. 11-33 W. 70 feet to an iron pin, the joint rear corner of Lots 5 and 6; thence along the joint line of Lots 5 and 6 N. 78-27 W. 150 feet to an iron pin, the beginning corner.
