T.A. Gilstrap, his heirs and assigns:

All those lots of land in the County of Greenville, State of South Carolina known as lot nos. 3, 4, 9, 10, 14 and 15 according to plat of Forest View made by T.C. Adams dated February, 1955 and recorded in the R.M.C. Office for Greenville County in Plat Book II, Page 105, and having according to said plat the following metes and bounds, to-wit:

Lots 3, 4, 9 and 10: Beginning at an iron pin on the southern side of Galphin Drive, at the joint front corner of lots nos. 4 and 5 and running thence S 10-16 E 367.7 feet to an iron pin on the northern side of Gilstrap Drive; thence with said Drive, N 89-14 E, 189.8 feet to an iron pin; thence N 39-39 E, 16 feet to an iron pin; thence N 10-16 W, 373.6 feet to an iron pin; thence N 55-16 W, 21.2 feet to an iron pin; thence S 79-44 W, 185 feet to the point of beginning.

Lots 14 and 15: Beginning at an iron pin on the southern side of Galphin Drive and running thence S 22-28 E, 182.4 feet to an iron pin; thence N 82-08 W, 260 feet to an iron pin; thence N 5-22 W, 131 feet to an iron pin; thence N 89-14 E, 200 feet to the beginning.

The above described deed is executed due to the fact that the property owners herein, the grantors and grantees, did combine lots nos. 57, 58, 59 and 60 of the E. M. Galphin property so as to form the subdivision of Forest View; this deed allots the respective persons their respective lots.
