to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THOMAS D. CHRISTOPHER, his heirs and assigns, forever:

ALL that lot of land situate, lying and being on the West side of Scarlett Street (formerly known as Forest Green Road), near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 222 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", pages 2 and 3 (also recorded in Plat Book "GG", pages 70 and 71) and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the West side of Scarlett Street, at joint front corner of Lots 221 and 222, and running thence with the line of Lot 221, S. 83-02 W., 164.1 feet to an iron pin; thence N. 2-28 W., 125 feet to an iron pin; thence with the line of Lot 223, N. 85-18 E., 156.2 feet to an iron pin on the West side of Scarlett Street; thence along the West side of Scarlett Street, S. 5-41 E. 78.6 feet to an iron pin; thence continuing with the West side of Scarlett Street, S. 6-58 E. 40 feet to the Beginning corner.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

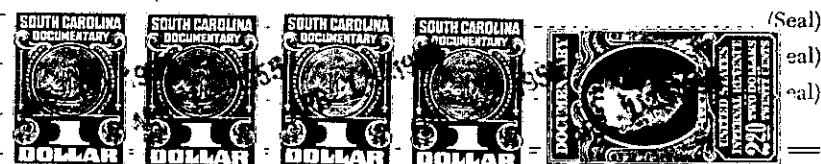
