

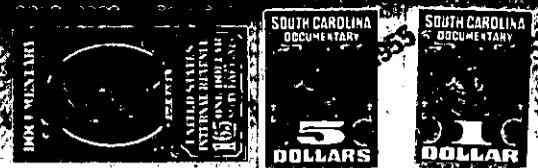

Know All Men by These Presents:

That J. O. Estes in the State aforesaid, in consideration of the sum of Two Thousand Eight Hundred Twenty-One & 01/100- - - - - DOLLARS, and assumption of mortgage described below: to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Archibald A. Williams, his heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 155, Paramount Park, as per plat thereof recorded in the R.L.C. Office for Greenville County, South Carolina, in Plat Book "A", page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeasterly side of Crosby Circle and running thence N. 50-30 W. 77.5 feet to an iron pin; thence around the curve of the intersection of Crosby Circle and Mayo Drive, the chord of which is N. 5-30 W. 35.4 feet to an iron pin; thence along Mayo Drive N. 39-30 E. 25 feet to an iron pin; thence continuing along Mayo Drive N. 60-05 E. 76.2 feet to an iron pin, joint corner Lots 155 and 190; thence along the line of Lot 190 S. 33-02 E. 80.2 feet to an iron pin, joint corner Lots 155, 156 and 190; thence along the line of Lot 156 and through a five foot reservation for utilities S. 40-0 W. 97 feet to an iron pin, the point of beginning.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given to C. Douglas Wilson & Co., on which there is a balance of \$7,678.99; said mortgage is recorded in Mortgages Volume 520, page 371.

Grantee to pay 1955 taxes.

This is the same property conveyed to the grantor by deed described in Deeds Volume 504, page 439.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
