to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said William E. Saylor, his heirs and assigns forever:

All that certain lot of land in Greenville County, State of South Carolina, on the Northern side of Gallivan Avenue, in the City of Greenville, being shown as lot # 60, on plat of North Park, made by Dalton & Neves, in May 1940, recorded in Plat Book K at Pages 48 and 49, and described as follows:

BEGINNING at a stake on the Northern side of Gallivan Avenue, 406.7 feet East from North Main Street, at corner of lot 59, thence with line of said lot, N. 19-46 E. 182.8 feet to a stake at corner of lot 65; thence with the line of said lot, S. 68-34 E. 60 feet to a stake at corner of lot 69; thence with the line of said lot, S. 19-46 W. 186 feet to a stake on Gallivan Avenue; thence with the Northern side of said Avenue, N. 65-32 W. 60.1 feet to the beginning corner.
