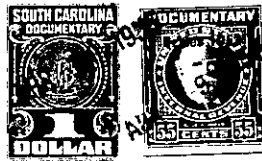
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

M. W. FORE, his heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 107 as is shown on a plat thereof entitled "Conestee Plat No. 2", made by madison H. Woodward, Engineer, recorded in the R. M. C. Office for Greenville County in Plat Book "T", at Page 383 and 384; and said property having the courses, dstances, metes and bounds, to-wit:

BEGINNING at an iron pin on Charles Drive at joint front corners of Lots No. 107 and 108 and running thence along the line of said Lot No. 108, N. 72-06 W. 194.1 feet to iron pin at back of Lot No. 107-B; thence along the rear line of said Lot No. 107-B, S. 18-04 W. 60 feet to iron pin at back corner of Lot No. 106; thence along the line of said Lot No. 106, S. 72-25 E. 198 feet to iron pin on Charles Drive; thence running with the said Charles Drive, N. 17-54 E. 60 feet to iron pin at point of beginning.

No residence to cost less than Two Thousand (\$2,000.00) Dollars, shall be erected on said lot nearer than twenty-five (25) feet to the front line, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
