That I, A. B. Cannon in the State aforesaid, in consideration of the sum of Ten Dollars and Exchange of property DOLLARS,

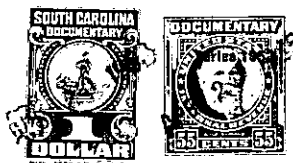
