All that piece, parcel or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot Nos. 121 and 122, on plat of University Park by Dalton & Neves dated November 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Brookside Circle at the joint front corner of Lot Nos. 122 and 123 and running thence with the joint line of said lots, S. 37-3/4 E. 140 feet to an iron pin; thence with the rear line of lot Nos. 92 and 93, S. 52-26 W. 150 feet to an iron pin; thence with the joint line of Lot Nos. 120 and 121, N. 37-3/4 W. 158.2 feet to an iron pin on the Southern side of Brookside Circle; thence with Brookside Circle N. 60-06 E. 75.7 feet and N. 58-56 E. 75.4 feet to the beginning corner.
