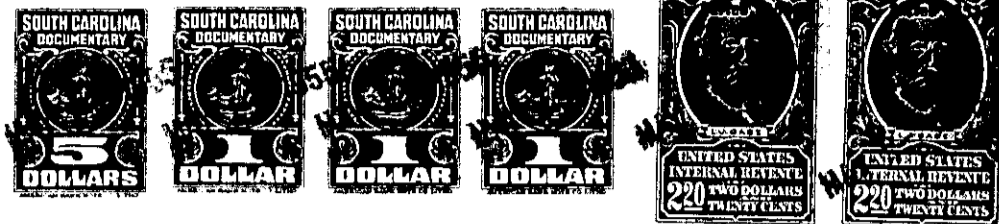

C. for said County in Deed Book 221 at page 217, and being shown on Plat of Property of V. E. Cox as lots Nos. 1, 4, 5, 11, 12, 13, 14, 21, 22, and 23, said plat made by H. S. Brockman, Surveyor, March 22nd 1950. For a complete description of said lots reference is hereby made to said plat, a copy of which is herewith attached.

ALSO all that other certain piece, parcel or lot of land situate, lying and being in the said County and State, Chick Springs Township, near the Town of Greer, S. C. and near or adjoining portions of the above described lots, and being the remainder of the same property that was conveyed to me by deed recorded in the said R. M. C. office in Deed Book 88 at page 541, six lots having been conveyed by me.
