R. E. FINCHER and GRACE M. FINCHER, their heirs and assigns forever,

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina in Greenville Township being known and designated as LOT NO. 14 on Birchwood Drive as shown on plat of Subdivision known as Kirkwood Heights according to Survey made by Pickell & Pickell, Engrs. October 1954 and recorded in the RMC Office for Greenville County in Plat Book "EE", at pages 110 and 111 and having the following metes and bounds:

BEGINNING at an iron pin on Birchwood Drive at joint front corner of Lots 15 and 14 and running thence South 49-18 East 150 feet to an iron pin; running thence North 40-42 East 60 feet to an iron pin on Edgewood Drive; running thence along Edgewood Drive, North 31-38 West 59.7 feet to an iron pin; continuing thence along Edgewood Drive, North 26-05 West 63.6 feet to an iron pin; running thence in a Northwesterly direction following a curve, the chord of which is North 82-42 West 41.8 feet to an iron pin on Birchwood Drive; running thence along Birchwood Drive, South 40-42 West 80.2 feet to an iron pin, the beginning corner.
