That WE, CHARLES L. TIDWELL AND W. K. STRINGFELLOW

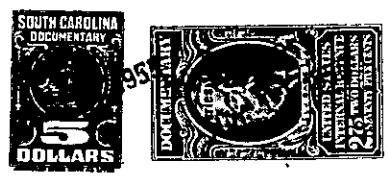
