BIDWELL in the State aforesaid, in consideration of the sum of TWELVE HUNDRED FIFTY AND NO/100, (\$1,250.00) - - - - DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

WILLIAM FREDRICK GLENN And DAKOTA CHRISTINE SMITH, THEIR HEIRS AND ASSIGNS,

ALL that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 64 as shown on plat of Pine Brook Development made by W. N. Willis, Engineer, on March 27, 1951, recorded in the R.M.C. Office for Greenville County in Plat Book "Z", at Page 148, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Western side of Brewster Drive, joint front corner of Lots 64 and 65, thence along line of said lots, S.53-37 W. 150 feet to an iron pin, joint rear corner of said lots; thence N.33-31 W. 82.5 feet to an iron pin, joint rear corner of lots 62, 64, 15 and 13; thence along line of lot 62, N.56-29 E. 150 feet to an iron pin on Brewster Drive; thence along Brewster Drive, S.33-31 E. 75 feet to an iron pin, the point of beginning.

This conveyance is made subject to the Restrictive and Protective Covenants applicable to Pine Brook and recorded in the R.M.C. Office for Greenville County, South Carolina, in Book of Deeds 443, at Page 307, and Book of Deeds 462, at Page 33.

Grantee to pay 1955 taxes.

Being the same property conveyed to W. T. Bidwell by A. D. Attaway by deed dated March 21, 1955 and recorded in the R. M. C. office for Greenville County in Vol. 521, page 240. (Christine K. Bidwell is unnecessary on said deed).

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
