in consideration of the sum of Nine Hundred and Seventy-five and no/100 in the State aforesaid, DOLLARS,

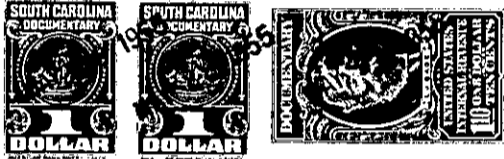
