That GYNN A. LINDSEY in the State aforesaid, in consideration of the sum of (\$400.00) Four Hundred and no/100-----DOLLARS,

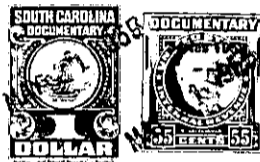
