PARK in the State aforesaid, in consideration of the sum of (\$1.00) One and no/100----- DOLLARS, and ~~expressing~~ love and affection for the Father and Mother of my Wife to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIE RUDOLPH AND HELEN RUDOLPH, their heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the South side of DeOyley Avenue, in that area recently annexed to the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 26 on Plat of Augusta Road Ranches, made by Dalton & Neves, Engineers, April, 1941, recorded in the R.L.C. Office for Greenville County, South Carolina, in Flat Book "000", page 47, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of DeOyley Avenue at joint front corner of Lots 25 and 26, said pin being 373.4 feet West from the Southwest corner of the intersection of DeOyley Avenue and Old Augusta Road and running thence with the line of Lot 25, S. 00-13 E. 200 feet to an iron pin; thence S. 89-47 W. 60 feet to an iron pin; thence with the line of Lot 27 W. 00-13 W. 200 feet to an iron pin on the South side of DeOyley Avenue; thence with the South side of DeOyley Avenue N. 89-47 E. 60 feet to the beginning corner.
