Duncan land; thence with Duncan, line 3.49 degrees 2.24.75 chs., to stake on Old nutherford hoad, the beginning corner, and containing Porty-Tho (42) cres, more or less, and teing 11 of the same tract of 1 and conveyed to me by J... Block and 1.1. lack by deed dated the 5th., day of January 1949 and recorded in the Office of N.1. Office Greenville County in Deed Book Vol., 369 at page 477.
